

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANFORD, TEXAS AUTHORIZING AN AGREEMENT WITH THE SANFORD-FRITCH INDEPENDENT SCHOOL DISTRICT AND THE CITY OF FRITCH TOCONDUCT A JOINT ELECTION.

WHEREAS, \$271.002(a) of the Texas Election Code states that a city is authorized to hold an election jointly with the elections of one or more other political subdivisions if the election of the city and the elections of one or more other political subdivision are to be held on the same day in all or part of the same territory, and the governing bodies of the city and one or more other political subdivisions enter into an agreement to hold the elections jointly in the election precincts that can be served by common polling places; and

WHEREAS, the City Council of Sanford, Texas has ordered that an election be held on May 3, 2025, for the election of _____ council members and mayor. The Sanford-Fritch Independent School District and the City of Fritch has ordered that an election be held on that same day, and

WHEREAS it would be advantageous to all three entities to hold a joint election that can be served by a common polling place.
