**Pursuant to SB 1667, which was signed during the 89th Legislative Session and took effect September 1, 2025, a District Clerk must post on their website a list of local agencies, including their mailing and email addresses, which a petitioner can include in their expunction order. Please note, pursuant to the amended Code of Criminal Procedure, the District Clerk is not liable if this list is not a comprehensive listing of every agency:**
