

**NOTICE OF FORECLOSURE SALE**

**ASSERT AND PROTECT YOUR RIGHTS AS A MEMBER OF THE ARMED FORCES OF THE UNITED STATES. **1. Property to Be Sold.** The property to be sold is described as follows: THE FOLLOWING DESCRIBED REAL PROPERTY IN EASTLAND COUNTY, TEXAS, TO -WIT: BEING ALL OF LOTS 9, 10, 11, 12, 13 AND THE EAST 10 FEET OF LOT 14, BLOCK 20, RANGER HEIGHTS ADDITION, CITY OF RANGER, EASTLAND COUNTY TEXAS, AND PORTIONS OF ALLEY WAYS VACATED BY THE CITY COMMISSION OF THE CITY OF RANGER, TEXAS, BY RESOLUTION OF RECORD IN VOLUME 395, PAGE 341 OF THE DEED RECORDS OF EASTLAND COUNTY, TEXAS.

**2. Instrument to be Foreclosed.** The instrument to be foreclosed is the Deed of Trust dated 11/10/2014 and recorded in Document 2014-003672 real property records of Eastland County, Texas.

**3. Date, Time, and Place of Sale.** The sale is scheduled to be held at the following date, time, and place:

**4. Terms of Sale.** The sale will be conducted as a public auction to the highest bidder for cash. Pursuant to the deed of trust, the mortgagee has the right to direct the Trustee to sell the property in one or more parcels and/or to sell all or only part of the property. Pursuant to section 51.009 of the Texas Property Code, the property will be sold in AS IS, WHERE IS condition, without any express or implied warranties, except as to the warranties of title, if any, provided for under the deed of trust.

**5. Obligations Secured.** The Deed of Trust executed by MARY A. HENNECH AND MICHAEL C. HENNECH, provides that it secures the payment of the indebtedness in the original principal amount of \$267,000.00, and obligations therein described including but not limited to (a) the promissory note; and (b) all renewals and extensions of the note. Reverse Mortgage Funding, LLC is the current mortgagee of the note and deed of trust and REVERSE MORTGAGE FUNDING, LLC is mortgage servicer.
