the above-noted date and time.**

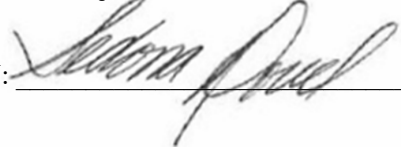
