

I am writing this letter to
Bail Bond Board in regards to
Judy going off Reymundo Ramirez Bond.
38 yrs old, D.O.B 01-07-1984,
for failure to appear. And who is
sitting in Litch County Detention Center
with out a bond. I have the conversations
recorded with Judy, Trent and Amanda
about Reymundo Ramirez file, and
why he failed to appear.

On October 23, 2022 we got pulled
over and Reymundo Ramirez had
a warrant out for his arrest for
failure to appear to court on Aug 4th 2022
at 9 am in the 70th district court.

So I did some research and talk
to the Judys Bonding Service. I also
retrieved the phone records from
metro pcs my phone company.
that I have been with for more
than 5 years. In the phone record
it states he reported from ~~the~~ June 2022
up until October 23 2022 the day
he was arrested for failure to appear.
Judy said he had reported June 26, 2022
then didn't report again for a month
later which was July 24, 2022 at 2 am
then she had to contact him on
July 27th to let him know he had
court coming up Aug 4th 2022.
so she went off his bond because she

he was with judys But I dont
 wanna go through judys any more.
 because its a problem with her not
 doing her job. this is peoples freedom
 & Her financial support or stability
 she is messing with Tam gonna
 also try to take her to small
 claims court for the money we
 put up to Bond him out for
 pain & suffering because we are
 losing our home Bills are getting cut
 off my kids are suffering and
 for lost wages. But what I really
 want is for the judge to give him
 back his Bond because he really
 isnt at fault for this he didnt
 run or show up because he didnt
 want to he didnt show up because
 she failed to tell him he had
 court & he works out in the mountains
 or out of the county surrounding
 areas doing ~~work~~ the guard
 railings for the highway he does
 get bad reception from time to time
 but they didnt go off his Bond
 when she claims he didnt report
 from June 26 to July 24 when
 my phone records say other wise
 but wants to go off his Bond for
 not getting a hold of him on the
 July 27, 2022 & its put on computer failed
 to appear please take my case and view
 if I have phone records, and the comparison

couldn't get a hold of him. But in
the computer it says Failure to
Appear. As I'm looking at the phone
records it showed he call in on
24th and the 31st of July. 3 days
after judge's had contact him about
court. They still had a chance to
let him know he had court coming up
on Aug 4th 2022 but failed to do so
she also said he hadn't reported
in a month from June 26, 2022 to
July 24 2022 but didn't go off his
bond then. But decides to go off his
bond because she couldn't get a hold
of him on July 27, 2022. Then the
number she had down for me 915-990-6403
was put down wrong that was their
mistake. because my number is
915-990-6403. the New Number
I have now was barley changed
a couple weeks ago. and the number
she has on file for him 915-990-4114
he still has that I'm still pay for.
so something don't make sense when
she said number wasn't good for him
he continued to report in out the way
up until October 23rd 2022 with out
telling him she had went off his bond
or that he missed his court date.
so for him to have missed his court
date was because she failed to inform
him about his court date for Aug 4th 2022
even after he called in on July 31st
