

10.22 ACRES - TRACT 7

BEING 10.22 acres of land out of the E. THORNTON SURVEY, Abstract No. 611, Eastland County, Texas, and being part of that tract described in a Warranty Deed with Vendor's Lien to Command Decisions, Inc., dated July 2, 2021 and recorded in Document No. 2021-002280 of the Official Public Records of Eastland County, Texas (OPREC) and described by metes and bounds as follows:

COMMENCING at a 5" pipe fence post found for the southeast corner of the said Command Decisions tract, the southwest corner of a tract described in a Warranty Deed to Rick Hogg, dated October 15, 2002 and recorded in Volume 97, Page 545 DREC, in the north line of County Road 495;


THENCE: South 88°55'08" West with the north line of County Road 495, a distance of 691.01 feet to a 1/2 inch pin with yellow cap stamped "CCC 4835" set for the POINT OF BEGINNING and being the southeast corner of this tract;

THENCE: South 88°55'08" West continuing with the north line of County Road 495, a distance of 268.43 feet to a 1/2 inch pin with yellow cap stamped "CCC 4835" set for the southwest corner of this tract, from which the southwest corner of the said Command Decisions tract bears South 88°55'08" West, a distance of 549.74 feet to a pipe fence post found, South 89°14'35" West, a distance of 956.85 feet to a pipe fence post found, South 59°04'18" West, a distance of 43.56 feet to a 1/2 inch pin with yellow cap stamped "CCC 4835" set, South 88°41'19" West, a distance of 188.05 feet to a 1/2" iron pin with a red plastic cap inscribed "Pfingsten" found;

THENCE: over and across the said Command Decisions tract the following courses and distances:

1. North 00°01'47" West a distance of 1,756.64 feet to a 1/2 inch pin with yellow cap stamped "CCC 4835" set for the northwest corner of this tract,
2. South 63°38'12" East a distance of 288.77 feet to a 1/2 inch pin with yellow cap stamped "CCC 4835" set for the northeast corner of this tract,
3. South 00°22'22" East a distance of 1,623.38 feet to the Point of Beginning.
