Judge Johnson called the meeting to order at 9:00 a.m. She noted that all members of the Court were present.

### Consider/Approve Employee Benefits Plan Renewal

Clint Allred spoke to the court. He said this year there will be an 8% rate increase in the health insurance premium. All benefits will be the same. The dental insurance will decrease 3%. Life insurance premiums will stay the same. The vision insurance will increase 4%. This year the county will not receive a surplus distribution from the TAC Risk Management Pool. Judge Johnson spoke about the benefits of TAC coverage. Nicholas moved to renew the employee health insurance benefits as presented by Security Insurance. Dawn seconded the motion which carried unopposed.

#### Consider/Approve renewal of contract with Childress County for Inmates Housing Services.

# Consider/Approve new Jury Pay Schedule as enacted by HB3474 in the 88<sup>th</sup> Legislative Session.

The clerk spoke to the court. She said she is requesting the Jury pay be increased as enacted by HB3474 in the 88<sup>th</sup> Legislative Session as follows:

\$20.00 for the first day if not selected - State reimbursement to the county \$14.00 \$25.00 for the first day if selected - State reimbursement to the county \$14.00 \$58.00 attendance rate (after the first day) - State reimbursement to the county \$52.00

Judge Johnson moved to approve the new Jury Pay scale as enacted by HB3474 and as presented by the clerk. Dale seconded the motion which carried unopposed.

#### **Approve Bills, Budget Amendments**

1) Library Memorial &Donations Revenue, 005-4-0000-0240, will increase by \$8,500.00 Library Memorial &Donations Expenses, 005-5-7041-0169, will increase by \$8,500.00 The revenue exceeds budget, offsets the summer program expenses.

2) EDC, 005-5-1002-0146, will increase by \$5,000.00 Litigation, 0052-5-1002-0183, will decrease by \$5000.00 This funding was approved for the EDC College Rodeo on February 2023.

Tim moved to approve the budget amendments as presented. Dale seconded the motion which carried unopposed.

Tim moved to approve the August, 2023 budget and financial Report/Treasurer's Report. Nicholas seconded the motion which carried unopposed.

Nicholas moved to approve the computer-generated bills. Dawn seconded the motion which carried unopposed.

Tim moved to approve the hand stamped bills. Dale seconded the motion which carried unopposed.

Tim moved to approve an invoice from Schafer Services for \$825.90. Dawn seconded the motion which carried with Dale abstaining.
