## CONSIDER PRESENTATION OF INSURANCE QUOTE FROM SECURITY INSURANCE:

Scotty Schilling made a motion to approve the insurance quote from Security Insurance on automobile coverage with changing 6 vehicles to liability coverage only. Dan Cockrell seconded the motion and the vote carried unanimously.

Scotty Schilling make a motion to approve the insurance quote from Security Insurance for building coverage less the \$62,000.00 blanket coverage, and adding terrorism coverage to the general liability, auto and property policy. Dan Cockrell seconded the motion and it carried unanimously.

## SET SALARIES FOR ELECTED OFFICIALS FOR 2024/2025:

Dan Cockrell made a motion to set salaries for the elected officials for the 2024-2025 fiscal year with a 4% increase in the amount of \$68,789.76. County Judge, County Attorney, and Sheriff all receive a state supplement to the base salary. County Treasurer also receives a supplement for District Court Bookkeeping. Scotty Schilling seconded the motion and the vote carried unanimously.

#### APPROVE 2024/2025 FISCAL YEAR OPERATING BUDGET:

Dori Roots made a motion to approve the 2024/2025 Fiscal Year Operating Budget. This budget will raise more total property taxes than last year's budget by \$6,839 or .0014 and of that amount \$10,358 is tax revenue to be raised from new property added to the tax roll this year. Juan Cantu seconded the motion and the vote carried with Dori Roots, Juan Cantu, Scotty Schilling, and Dan Cockrell voting in favor.

### APPROVE THE ORDER TO ADOPT THE TAX RATE:

Dori Roots made a motion to set the tax rate for the General Fund at .6285529, the Special Road and Bridge at .15 and the Farm to Market .16. The total tax rate will be set at .93955290 which is not above the No New Revenue tax rate. Dan Cockrell seconded the motion and it carried by a unanimous vote.

# ADOPT THE 2024 TAX RATE (THE RATE DOES NOT EXCEED THE NO NEW REVENUE RATE OR VOTER APPROVAL RATE:

Dori Roots made a motion to adopt the 2024 tax rate of .93955290. Dan Cockrell seconded the motion and it carried by a unanimous vote.

### ENTER INTO EXECUTIVE SESSION TO CONSIDER PERSONNEL MATTERS:

A. Pursuant to the authority granted under government code chapter 555.074 the Commissioners' Court will convene in closed session to discuss the above agenda item.

Juan Cantu made a motion to go into Executive Session at 11:58 a.m. to discuss the above agenda item. Dan Cockrell seconded the motion and the vote carried unanimously.

Dan Cockrell made a motion to return to open session at 1:09 p.m. Juan Cantu seconded the motion and vote carried by a unanimous vote.
