2. This Application must be completed in full, printed, and legible, with all required attachments, before it will be considered by the Game Room Administrator. Incomplete or illegible applications will not be accepted.
3. The Application must be submitted by the applicant in person, at 121 N Austin Street, Room 103, Jasper, Texas. Applications will not be accepted by mail, fax, or electronic submission.
4. Upon acceptance of an application with the required fee, the applicant will receive a receipt. A RECEIPT IS NOT A PERMIT and DOES NOT authorize operation of a game room, except as explicitly set forth in, and limited by, the Grace Period provision of Subsection 8.01(a) of the regulations.
5. This application is submitted under penalty of perjury as defined by Chapter 37.02 of the Texas Penal Code.
