PRESENTED TO COMMISSIONERS COURT
ACTIVITY FOR MAY 2024

In accordance with *Texas Local Government Code Title 4 Finances, Subtitle B County Finances, Chapter 114. County Financial Reports, Subchapter A. General Provisions, Section 114.001* (b), which states, “A monthly report must be filed within five days after the last day of each month”.

Section 114.003 of the same aforementioned Code states, “A county official or other person who is required under this subtitle to provide a report, statement, or other information to the county auditor and who intentionally refuses to comply with a reasonable request of the county auditor relating to the report, statement, or information, commits an offense.”

In accordance with *Texas Local Government Code Title 4 Finances, Subtitle B County Finances, Chapter 113 Management of County Money, Subchapter A General Provisions, Section 113.022* Time for Making Deposits. (A) “A county officer or other person who receives money shall deposit the money with the county treasurer on or before the next regular business day after the date on which the money is received. If this deadline cannot be met, the officer or person must deposit the money, without exception, on or before the fifth business day after the day on which the money is received. However, in a county with fewer than 50,000 inhabitants, the commissioners’ court may extend the period during which funds must be deposited with the county treasurer, but the period may not exceed 15 days after the date the funds are received.”

SUMMARIES OF GENERAL FUND, DISTRICT COURT & MAIN ROAD & BRIDGE FUND

As of MAY 31, 2024

GENERAL FUND

As of May 31 the fiscal year is 66.67% completed. The total general fund revenue budget is \$10,835,276.99. Total actual revenues collected to date are \$ 9,197,563.69 or **84.89%** of budget. Total expenditures to date are \$ 6,645,575.78 or 61.40% of the forecast. The County's actual **Revenues** are \$ 2,551,987.91 greater than actual **Expenditures** so far for this fiscal year.

As of May 31, 2023 total revenues to date were 89.30 % of budget.
As of May 31, 2022 total revenues to date were 79.33 % of budget.
As of May 31, 2021 total revenues to date were 79.23 % of budget.
As of May 31, 2020 total revenues to date were 88.65 % of budget.
As of May 31, 2019 total revenues to date were 88.10 % of budget.

DISTRICT COURT

As of May 31 the fiscal year is 66.67% completed. The total District Court revenue budget is \$ 523,139.00. Total actual revenues collected to date are \$411,754.15 or **78.71%** of budget. Total expenditures to date are \$ 343,138.34 or 65.94% of the forecast. The District Court's actual **Revenues** are \$ 111,384.85 greater than actual **Expenses** for this fiscal year.

As of May 31, 2023 total revenues to date were 78.75 % of budget.
As of May 31, 2022 total revenues to date were 66.96 % of budget.
As of May 31, 2021 total revenues to date were 72.33 % of budget.
As of May 31, 2020 total revenues to date were 68.80 % of budget.
As of May 31, 2019 total revenues to date were 78.24 % of budget.

MAIN ROAD AND BRIDGE FUND

As of May 31 the fiscal year is 66.67% completed. The total Main Road & Bridge revenue budget is \$2,608,686.71. Total actual revenues collected to date are \$ 2,378,741.31 or **91.19%** of budget. Total expenditures to date are \$ 1,738,403.59 or 66.64% of the forecast. The Main Road and Bridge Fund actual **Revenues** are \$ 640,337.72 greater than actual **Expenses** for this fiscal year.

As of May 31, 2023 total revenues to date were 90.27 % of budget.
As of May 31, 2022 total revenues to date were 82.40 % of budget.
As of May 31, 2021 total revenues to date were 86.92 % of budget.
As of May 31, 2020 total revenues to date were 90.43 % of budget.
