The following agenda items were considered, reviewed, discussed, and action may be taken as appropriate:

- A quorum will be established, and the meeting of Milam County ESD #1 will be called to order.
   A quorum was present with all board members in attendance. President Kain Dodd called the meeting to order at 7:00p.m..
- 2) Pledge allegiance to the American and Texas Flag.
- 3) Recognition of citizens and Citizen Comments. *No citizens were present.*
- 4) Consider the minutes of previous Milam County ESD #1 board meetings. Act on any corrections, changes, or approval of said minutes.

  The minutes of the previous regular meeting held on March 19th, 2024 were presented by Commissioner Kain Dodd. There were no additions, corrections, or amendments to the minutes. Commissioner Gerren made a motion to approve the minutes, seconded by Commissioner Knapek, all were for none were opposed, motion passed.

  - a. EMS Contract Committee Mikel Reed and Kain Dodd

- b. Station Committee Stephen Hanel and Rebecca Gerren

  The station committee will tour Milam and Robertson County EMS stations.
- c. Communications Committee Stephen Hanel and Kain Dodd

  <u>The Milam County Communications Committee currently does not have any meetings scheduled.</u>
- d. Fire Department Liaison Committee Kimberly Knapek and Mikel Reed <u>Commissioner Reed met with Gause VFD on April 1st. Commissioner Reed and Knapek will meet with Thorndale VFD next.</u>
- Appraisal District.

  Per Section 6.078 of the Texas Tax Code an Interlocal Agreement between the District and the Appraisal District is not necessary at this time. A motion was made by Commissioner Hanel and seconded by Commissioner Reed for the District to notify the Appraisal District of our newly formed Emergency Services District via letter with a map of the Districts boundaries that meet Section 6.078 requirements. All were for, none were against, the motion passed.
- 7) Discuss creation of a website for the District that meets SB2 and HB305 requirements.

  The District has received 2 quotes for a website creator. A motion was made by Commissioner Dodd and seconded by Commissioner Reed to table agenda item #7 until the next meeting. All were for, none were opposed, the motion passed.
- 8) Discuss creation of a Milam County ESD #1 logo/patch.

  <u>Commissioner Dodd is still working with a logo designer. He will present a draft at a later date for review.</u>
- 9) Report on status of Treasurers fiduciary bond to be set by the County Judge and filed with the Milam County Clerk.

  Treasurer Reed will move forward once he has the minutes from Commissioners Court.
- Review, revise, and approve a request for proposal for certified public accounts to conduct audits for District and contractor(s) to District.

  The District reviewed a quote from ORW CPA. A motion was made by Commissioner Hanel and seconded by Commissioner Reed to table agenda item #10. All were for, none were opposed, the motion passed.
- 11) Set the fiscal year for the District's operations.

  The Board discussed setting the District on a fiscal or calendar year. A motion was made by Commissioner Knapek and seconded by Commissioner Dodd to table agenda item #11.

- 12) Selecting depository bank for District accounts and action related to signatory authority for the same.

  <u>Treasurer Reed will take a copy of the previous meeting minutes to the bank and request an application.</u>
- 13) Review, discuss, and take appropriate action on insurance quotes for the District.

  <u>President Dodd has not received any additional insurance quotes for the District. He will report back to the board at the next meeting.</u>
- 14) Report on status of ESD Commissioner training certificates from the 2024 Texas State Association of Fire and Emergency Districts (SAFE-D) Conference.

  <u>Commissioner Gerren confirmed she submitted her training certificates for CE credit.</u>
