


NOTICE OF MEETING

1. Call the regular meeting to order with prayer.
2. Pledge Allegiance to the United States and Texas Flags.
3. Read and approve Minutes from previous meetings.
4. Read and approve the bills.
5. Citizen's Forum.
6. Discuss and take any needed action regarding a Burn Ban.
7. Hear from representatives of Merit Advisors concerning prospective Bolt and Data Energy project and take any needed action.
8. Consider the state of effective lines of succession for the elected officers of the County and take any needed action for ratification or establishment.
9. Present the option for Flood Plain Modeling by US Army Corp of Engineers and take any needed action.
10. Review new protocols with Betty Hardwick Center pertaining to Jail Psychiatric Clinic Services to inmates and price structure and interlocal agreement and take any needed action on the agreement.
11. Consider Sheriffs' and Constables' Fee for continuance or changes and take any needed action.
12. Slate the publication of notice for bids – Fuel and Lawn Care for the Courthouse and the Johnson and Lynch cemeteries.


