


NOTICE OF MEETING

Notice is hereby given that a Regular meeting of the above-named Commissioners Court will be held on Tuesday the 26th day of May 2026, at 9:00 a.m. in the Shackelford County Courthouse Courtroom, Albany, Texas at which time the following subjects will be discussed, to-wit: (items do not have to be addressed in the same order as shown on this notice.)

1. Call the regular meeting to order with prayer.
2. Pledge Allegiance to the United States and Texas Flags.
3. Read and approve Minutes from previous meetings.
4. Read and approve the bills.
5. Citizen's Forum.
6. Discuss and take any needed action regarding a Burn Ban.
7. Discuss the renewal of Community Service Agreement with Walker Sayle and take any needed action.
8. Hear from Shackelford County Library about improvements and building repairs needed and take any needed action.
9. Hear requests for Courthouse access on certain dates in June and July for Day Camp and for Fandangle crowd tours and take any needed action.
10. Consider the addition of a part-time position in the Treasurer's Office for the purpose of orientation for the next Treasurer and take any needed action.
11. Executive session – Discuss pursuant to Texas Government Code Section 551.071, to consult with the County's Attorney regarding pending or contemplated litigation settlement offers, and specific legal matters-re: formal complaint from CLEAT.
12. Take any action deemed necessary regarding matters weighed in executive session.
13. Elected Officials' report.


