Ordinance No. 399

The City of Waskom, Texas ordered an election to be held on May 3, 2025 for the purpose of electing one Mayor and three Alderman. Applications for a place on the ballot were accepted during the period of January 15, 2025 to February 14, 2025. There was only one application received from Keith Slone for the Mayor position and three applications received from Shirley Hall, Ryan Smith, and S. Cade Martin for the Alderman Section.

2.053 of the Election Code states that the governing body of the political subdivision by order or ordinance may declare each unopposed candidate elected to office.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to Keith Slone, for the position of Mayor.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to Shirley Hall for the position of Alderman.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to Ryan Smith for the position of Alderman.

WHEREAS, THE City Secretary has certified to the governing body that there is no opposition candidate to S. Cade Martin for the position of Alderman.

BE IT ORDAINED by the Board of Aldermen of the City of Waskom, Texas:

Section 1: That the Board of Aldermen has reviewed the certifications of the City Secretary and hereby declares that Keith Slone is elected to the office of Mayor and Shirley Hall, Ryan Smith, and S. Cade Martin are elected to the office of Alderman.

Section 2: That the Board of Aldermen hereby declares that no City Election will be held on May 3, 2025, since there are no opposing candidates.
