### **ORDINANCE No. 395**

# AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF WASKOM, TEXAS, ORDERING A GENERAL ELECTION, ESTABLISHING PROCEDURES FOR THAT ELECTION AND PROVIDING AN EFFECTIVE DATE

**WHEREAS,** by this Ordinance, it is the intention of the City Council to call the general election, to enter into a joint election agreement with Waskom ISD and to establish and set forth procedures for conducting the election.

NOW, THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF WASKOM, TEXAS:

#### Section 1:

<u>Election Order:</u> An election is hereby ordered to be held on May 03, 2025, for the purpose of electing three (3) Alderman for two-year terms, and one (1) Mayor for two-year term.

Joint Election: The City of Waskom will enter into a joint election agreement with the Waskom Independent School District
