For the record: Judge Sims commented on hail damage to multiple County buildings in February 2024. The Counties Insurance is with TAC, a/k/a Texas Association of Counties, TAC came out

and reviewed damages. TAC set aside some funds to repair buildings. They use 4T as well as the county has in the past. 4T Company is owned by Scott Franklin the same Company that put the roof on the Historical Court House. Texas Association of Counties continues to use 4T for their good work.4T came in under the dollar amount they had set aside for the whole project. Working with Brett Anderson which is the claim adjustor at TAC, Mr. Anderson recommended 4T be the overseer of the project. PMR is the Contractor under 4T. The County will only be out the deductible expense of \$25,000 for all the projects. Willoughby will be first on the list and then move to the main jail. They will also look at the roof at the Annex jail. Commissioner Ebarb inquired about the difference in the dollar amount being under the amount set aside. Judge Sims said they will use a higher quality material than original planned.

For the record: Comm. Hatfield commented that he doesn't understand why the County has to give up the Courthouse for 166 days. And he's still waiting on the City to come out and put up handicap signs around the courthouse. Comm. Hatfield commented that Ms. Graff called years ago for the signs. Comm. Hatfield commented that the city put up signs but put Sack Crete around the base and it looked horrible. Maintenance department took them down. Comm. Hatfield said he cannot support 166 days for something that doesn't benefit the County one bit. Judge Sims commented that they ask for a little more time to use the man lift to put the lights up. Comm. Ebarb ask that the city not start on the start date and take over the east parking lot and half of the other parking lot. It's a cluster when Juror's or called for Jury duty or when the Federal Court holds court in the building.

Judge Sims stated that the agreement is only for the Courthouse and light display. It is not for the merry go round and skating rink. Comm. Ebarb ask that the city wait as long as possible because of the need for parking. Comm. Timmins commented to remember that Marshall is also the County Seat.
