

For the record:

* Judge Sims commented that this is the Counties assistant District that this election is calling for. This would raise funds for unincorporated areas of the County through a sales tax that would increase the current sales tax is 6.25%. That whole 6.25% goes to the State, the County gets 0%. If this is approved the County will receive that additional 2% and Judge Sims would ask the court to committing 100% of those funds to repairs for County Roads. This item is about calling for the election.

* Commissioner Ebarb commented that he would like to see at the next Commissioners Court meeting to pass a resolution that the County spend 100% on road construction and a paragraph stating that it's not with intentions of cutting present funding for R&B, so it's clear that money is not being exchanged from one to the other. The court is committed to leave the R&B budget funded like it has been and this additional money will be spent 100% on roads.
