

Item B: Road and Bridge Department: 2023 Construction Completed & in Progress: Luke Davis gave report from June 28, 2023 to July 20, 2023 on construction completed & In Progress, maintenance and repairs of county roads, bridges and right-of-ways also concerning condition of equipment. Exhibit B

Road and bridge has issued 54 road permits. Road and Bridge continues to move forward on summer construction. As of July 26, 2023 crews have completed 4.369 miles and have 11.465 miles in progress. Contractors have completed Paige Rd.

Luke Davis noted the chip seal process is moving along, Contractors are able to do a couple of miles a day. Mr. Davis also committed that Saturday, July 29, 2023 was the last day to drop off storm debris at disposal locations. Judge Sims addressed the slowing of traffic coming and going at the disposal locations, and whether or not they should stay open longer. Mr. Davis commented that it has slowed down compared to what it was. Anyone that had big projects going have completed them. Everyone is now being directed to the City.

Commissioner Ebarb asked if rebuild work will start on Airlite Rd, Macedonia Rd, and Simmons Rd. Two are in Pct. 4. Mr. Davis stated that work will start.

Commissioner Hatfield stated Old Town Rd looked close to being complete from Panola County across 451 near four corners where Strickland Springs and 31 come together. Commissioner Hatfield ask if extra cement will be added due to underground spring. Mr. Davis stated that extra cement has been added. More may be added at a later date. Commissioner Hatfield asked that they keep an eye on it. Road work should be done on Hwy 31 this week.
