**RESOLUTION  
SETTING THE TAX RATE OF THE  
ROCHELLE INDEPENDENT SCHOOL DISTRICT  
FOR THE YEAR  
2024-2025**

WHEREAS, the valuation of taxable property within the boundaries of the  
ROCHELLE INDEPENDENT SCHOOL DISTRICT  
has heretofore been determined; and

WHEREAS, a Budget for said District has been prepared and adopted on August 15, 2024  
by the Board of Trustees; and WHEREAS, it is now desired by the Board of Trustees of the  
ROCHELLE INDEPENDENT SCHOOL DISTRICT  
to set the tax rate for the coming year:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF  
THE ROCHELLE INDEPENDENT SCHOOL DISTRICT:

1. That the following rates on the \$100.00 valuation be adopted and levied for the fiscal year 2024-2025
  - (a) An ad valorem tax of and at the rate of 0.9369 on the \$100.00 valuation, estimated in lawful currency of the United States, be allocated for the support and maintenance of the Public Schools of Rochelle Independent School District; and
2. That said ad valorem tax rate be comprised of:

\$.6969 for the purpose of maintenance and operations, and  
\$.24 for the purpose of payment of principal and interest on debt service; and
3. **THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 4.5% PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$0; and**
4. The current voter-approval tax rate is \$.6669 and the adopted tax rate will trigger a Voter-Approval Tax Ratification Election; and
5. That the tax assessor for the unit be notified of the tax rate adopted.

ROCHELLE INDEPENDENT SCHOOL DISTRICT  
ORDER OF VOTER-APPROVAL TAX RATE ELECTION

A special election is hereby ordered to be held on November 5, 2024, pursuant to Texas Tax Code Sections 26.05 and 26.08 to approve the ad valorem tax rate for Rochelle ISD because the adopted rate exceeds the RISD Voter-Approval Tax Rate ("VATR").

At the Election, the ballot proposition shall be submitted to the qualified voters of the District using the language required by statute:

"Ratifying the ad valorem tax rate of \$.9369 in Rochelle ISD for the current year, a rate that will result in an increase of 21.3 percent in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$249,720."

Early voting by personal appearance will be conducted beginning on October 21 and ending on November 1, 2024.



