An offense under this section is a Class C misdemeanor.	<b>Penalties/Fees-</b> Initial fee of \$150 w/renewal fee of \$150
<a href="#"><u>Floodplain Ordinance</u></a>	Texas Water Code Section 16.315	02-18-2011	<b>Violation-</b> Non-compliance with the provisions set forth in the floodplain ordinance listed constitutes a misdemeanor.	<b>Penalties/Fees-</b> Enforces no more than \$2,000 for each violation. Each day a violation occurs is a separate offense.

<a href="#"><u>Manufactured Home Rental Community Standards</u></a>	Tx Local Government Code 232.007	10-13-2020	<b>Violation-</b> Failure to meet minimum infrastructures standards for manufactured home rental.	<b>Penalties/Fees</b> The application for a Manufactured Home Rental Community shall be \$250.00. The fee shall be paid when the application for approval is submitted.

<u><b>Recreational Vehicle Park Regulations</b></u>	Tx Local Government Code Chapter 232	01-23-2024	<b>Violations-</b> Failure to comply with the standards and regulations of the local municipality through zoning codes and ordinances.	<b>Penalties/Fees-</b> Retainer for Engineer Review and Inspection Fees: \$5,000  (a) A fee of \$150, plus \$20 for each proposed Recreational Vehicle Space will be assessed on filing the development application (b) A fee of \$80.00 will be assessed for each inspection to issue the Certificate of Compliance. (c) Waiver/variance fee \$1,000 non-refundable, waiver/ variance must be approved in Commissioners Court and filed with the County Clerk to be considered complete (d) A fee of \$25.00, plus \$4.00 per each additional page will be assessed for filing the Certificate of Compliance with the County Clerk
