The investment statements supporting this report have been reviewed and reconciled, and all investment activity is in compliance with the Texas Public Funds Investment Act (Texas Government Code Chapter 2256) and the Live Oak County Investment Policy. The County's investment strategy remains conservative and passive in nature, with primary objectives of safety, liquidity, and yield. All investments are maintained with approved financial institutions, and all certificates of deposit are held at federally insured depository institutions with principal and accrued interest fully secured in accordance with applicable law. To the best of my knowledge and belief, the information contained in this report is true, correct, and complete.

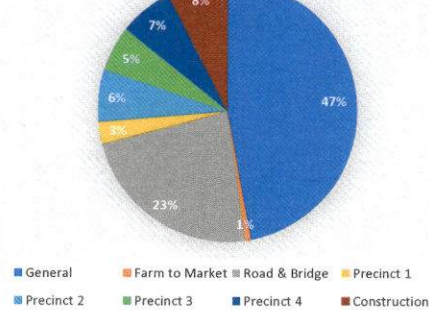

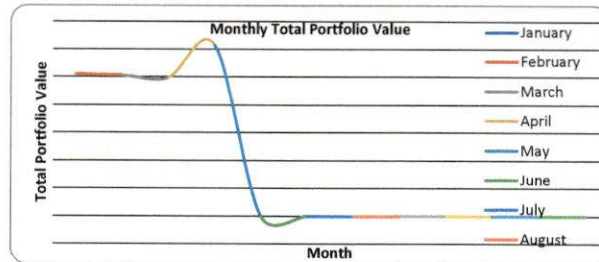

Portfolio Allocation by Fund



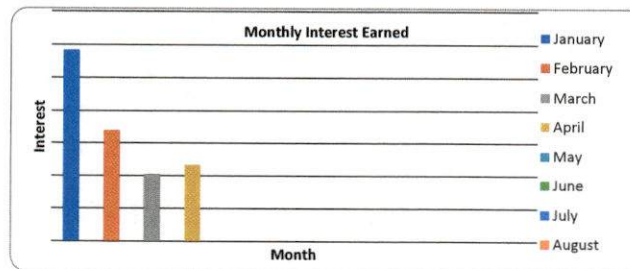

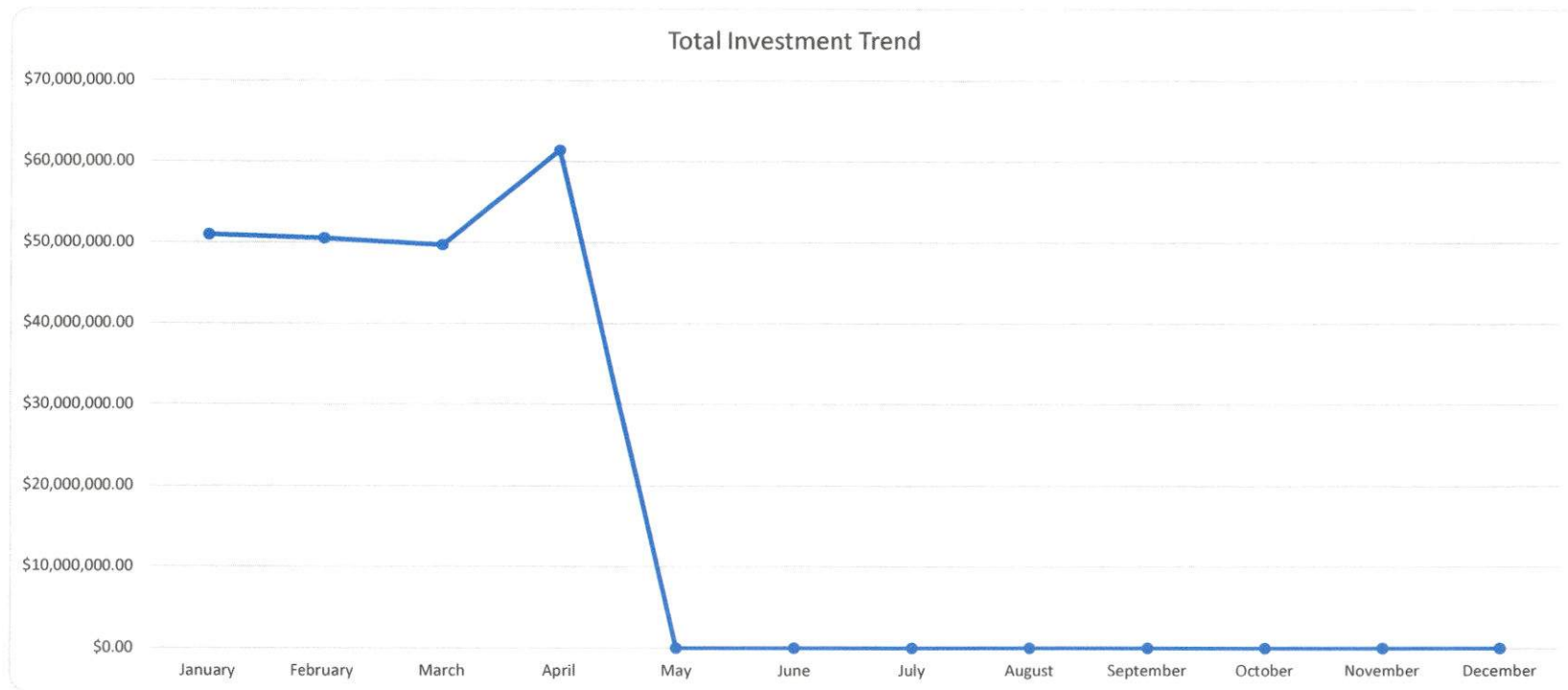
