All Pre-Trial Motions are to be filed at least ten (10) days prior to Trial date.

The Court should be notified at least seven (7) days prior to Trial date if a Bench Warrant is necessary.

No Children under the age of 12 years old will be allowed in the courtroom.


Failure to appear punctually at the above trial setting may result in the issuance of a Judgement NISI (bond forfeiture) and a warrant for arrest of the Defendant.

**SPECIAL NOTICE: The County Attorney and all defense counsel are instructed to arrange guilty pleas as set forth in Rule 6.7 of the 97<sup>th</sup> District's Local Rules.**

In the event a jury case is not tried at such time stated above, it is ordered set for trial on the next successive Jury date: **October 30, 2018**

**NOTICE: Only the Archer County Judge has the authority to excuse an Attorney or Defendant from appearing.**
