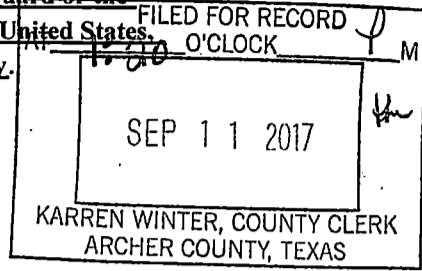


NOTICE OF [SUBSTITUTE] TRUSTEE'S SALE
