 ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Borden County, Texas, held on 11th day of September on a motion made by Commissioner BELEW and seconded by Commissioner Adcock, the following order was adopted:
