 ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Borden County, Texas, held on **11th day of April** on a motion made by Commissioner Adcock and seconded by Commissioner REYES, the following order was adopted:

NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Borden County, Texas, that such Treasurer's Report for the month ended, **March 31, 2017**, be, and hereby is, approved an accepted as correct.


