 ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Borden County, Texas, held on the 12th day of December on a motion made by Commissioner Adcock and seconded by Commissioner Reyes, the following order was adopted:
