

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, on August 10, 2022, Codie Ryse Shaw executed a Deed of Trust to secure in the payment of that certain Promissory Note of even date therewith in the principal sum of **\$110,649.52 (One Hundred Ten Thousand Six Hundred Forty Nine Dollars and Fifty Two Cents)**, said Deed of Trust being filed for record in Record Number 2022-00000952, of the **Carson County Clerks Records**; and

WHEREAS, the undersigned has been appointed Substitute Trustee in the place of the said original Trustee, upon the contingency and in the manner authorized by the Deed of Trust; and


