INDUSTRY PROJECT DISCUSSION (No. 1)

Devon Energy & BHP Billiton –rapping up frac jobs around Cottonpatch Road; Weikel frac on Catholic Church Lane and Ibrom frac off of FM 240; 1 rig running off of Kubala Store Road; bringing in probably 3 more rigs around April; building a pad now off of Emil Blank Road; more construction starting off of FM766 and Herman Road

Conoco Phillips – currently operating 3 rigs and by mid-January a total of 5 rigs and plan to operate 5 rigs thru 2017 within DeWitt and Karnes Counties

Pioneer Natural Resources – 2 jobs finishing up at FM 2980 and Sunday Lane; 2017 – 2 rigs planned to come in within the first quarter; one location will be around SH 119 and SH 108 (Koopmann); planning on 18 new wells for 2017 mostly in Karnes County

DeWITT COUNTY COMMISSIONERS (No. 3)

Precinct No. 3 -- re-worked Simpson Ranch Road; normal maintenance of road (drainage, vegetation, blading etc.); waiting on H & C to complete work on Sunday Lane




