INDUSTRY PROJECT DISCUSSION (No. 1)

Pioneer Natural Resources – hopefully 2 rigs in early 2017; no rigs at the moment; normal routine operations until end of year; holding off fracing at this time

Devon Energy & BHP Billiton – 1 rig located on Kubala Store Road until end of year; 5 frac spreads on Catholic Church Lane and Cottonpatch area; hopefully off of Catholic Church Lane in middle of October; fracing of Weikel pad thru December and Steen pad on Cheapside Road beginning October

Conoco Phillips – 2 rigs operating at this time; planning on picking up 2 more rigs in October; balance of 3 rigs at the end of the year within DeWitt and Karnes Counties; plans on picking up 1 more rig in January 2017; no new pad sites planned only on existing pad sites

DeWITT COUNTY COMMISSIONERS (No. 2)

Precinct No. 1 – Brannon Brothers is completing 4 ½ miles on Bellevue Cemetery Road; hopefully completed by end of month; one course of rock down on Schulle Road, trying to complete ½ mile on DuBose Ranch Road; ½ mile on Meyer Road

Plans for next year budget – complete paving project on Smith Ranch Road; Schlinke Road (re-dress and stabilizer); uncompleted project on McCurdy and Morgan Roads (cement stabilizer and paved)

Gravel roads – Seidel, Kubala Store and DuBose Ranch Roads

Precinct No. 2 – finished Rathkamp and all the other roads discussed last time; hopefully finish with this budget year - Nelson Road .6 mile; Vahalik Road .6 mile; $\frac{1}{2}$ mile of Dagg Road;

Plans for next year budget -- W. Blank (3.8 miles)

Precinct No. 3 – finished Sunday Lane; VFW Road (waiting on contractor to get back to this road to finish the work that was started a couple months ago); regular maintenance on the county roads

Gravel Roads – Scheffler and Cabeza Roads

Mr. Janak, CETRZ Advisory Board Member No. 2 stated that everyone was pleased with the roads. Comments that he has heard was that the posted speed limit signs are great but hopefully the county has not spent a lot of money on them if the cops do not work traffic on the roads.


