

LLC, to Cordillera High Hills Investments, LLC, dated June 7, 2017 and recorded in Volume 1820, Page 107 of the Official Records of Fayette County, said 2.577 acre tract being more particularly described by metes and bounds as follows: Beginning at a 1/2" iron rod found for the Southeast corner of a (called) 0.139 acre Stephanie Simmons tract (Vol. 1563, Pg. 791 F.C.O.R.), an inside corner of said Cordillera High Hills Investments tract, an inside corner of the herein described tract and the PLACE OF BEGINNING, said point having a coordinate value of N=13,876,136.07 feet and E= 2,641,881.95 feet according to the Texas State Plane Coordinate System - South Central Zone - NAD 83 (2011);

Thence North 15 degrees 29 minutes 28 seconds East, 88.33 feet along the common line between said Cordillera High Hills Investments tract and said Simmons tract to a 1/2" iron rod found in the curving South right-of-way line of "Spur Highway 92" (80' Right-of-way) for the Northeast corner of said Simmons tract, the Northwest corner of said Cordillera High Hills Investments tract, the Northwest corner of the herein described tract and the beginning of a curve to the left, from which a 1/2" iron rod found bears South 15 degrees 29 minutes 28 seconds West, 2.14 feet;
