**ORDER OF AN ELECTION PROPOSING TO CREATE A HOSPITAL DISTRICT  
THAT IMPOSES A PROPERTY TAX**

An election is hereby Ordered to be held on Thursday, June 13, 2019, for the purpose of:

The creation of the Fayette County Hospital District and the levy of annual property taxes for hospital purposes at a rate not to exceed 25 cents (\$.25) on each \$100 valuation of all taxable property in the district.

Early voting by personal appearance will be conducted on weekdays at the Fayette County Courthouse, Elections Administrator's Office, 151 N. Washington St., Room 108, La Grange, Texas 78945, between the hours of 7:00 AM and 6:00 PM, on May 28, 29, 30, and 31, 2019, and on June 3, 4, 5, 6, and 7, 2019.

Voting on Election Day by personal appearance will be conducted on Thursday, June 13, 2019 between the hours of 7:00 AM and 7:00 PM at the following polling locations:




Applications for ballots by mail must be received no later than 6:00 PM on May 31, 2019.




