## Precinct Description of 201 East- La Grange

The precinct boundaries for election precinct 201E La Grange are described and composed of boundary lines as follows:

BEGINNING at the center of the intersection of East Travis Street, South Ellinger Road and FM 159;

Following north along the center line of FM 159 to the intersection at Cedar Creek;

Following northwesterly along the center line of Cedar Creek to the northwest corner of Census Block 2012;

Following north along the edge of Census Blocks 2012, 2001, and 2000, to the intersection at Janssen Lane;

Following north along the center line of Janssen Lane to the north most point of Census Block 2049;

Following southerly along the edge of Census Block 2049 to the intersection at Bucky Road;

Following northeasterly along the center line of Bucky Road to the intersection at Cottonwood Road;

Following southeasterly along the center line of Cottonwood Road to the intersection at SH 159;

Following north along the center line of SH 159 to the intersection of Rutersville Hills Lane and Census Block 1009;

Following northwesterly along the edge of Census Block 1009 to the intersection at Harms Road;

Following north along the center line of Harms Road to the intersection of Sand Rock Road;

Following northwest and southwest along the center line of Sand Rock Road to the intersection at Mueller Road;

Following north along the center line of Mueller Road to the intersection at FM 2981;

Following east along the center line of FM 2981 to the intersection at SH 237;

Following north along the center line of SH 237 to the intersection at SH 159

Following east along the center line of SH 159 to the intersection at Park Prairie Road;

Following south and east along the center line of Park Prairie Road to the intersection at Census Block 1032;

Following south along the edge of Census Block 1032 to the intersection at Cedar Creek Reservoir;

Following southeast along the center line of Cedar Creek Reservoir to the intersection at Cedar Creek;

Following south along the center line of Cedar Creek to the intersection at the Colorado River;

Following northwesterly along the center line of the Colorado River to the southwest point of Census Block 4039;

Following northeast along the edge of Census Blocks 4039 and 4028 to the intersection at West Lower Line Street;

Following north along the center line of West Lower Line Street to the intersection at South Main Street;

Following south along the center line of South Main Street to the intersection at West Live Oak Street;

Following east along the center line of West Live Oak Street to the intersection of South Washington Street;

Following south along the center line of South Washington Street to the intersection of West Eblin Street;

Following east along the center line of West Eblin Street to the intersection of East Eblin Street;

Following east along the center line of East Eblin Street to the intersection of north most point of Census Block 3041;

Following southeast then southwest along the edge of Census Block 3041 to the intersection of Census Block 3042;

Following south along the edge of Census Block 3042 to the intersection of Census Block 3043;

Following east along the edge of Census Block 3043 to the intersection of Census Block 3013;

Following northeast along the edge of Census Block 3013 to the intersection of Census block 3025;

Following northeast and then northwest along the edge of Census Block 3025 to the intersection of Leopard Lane;

Following north along the center line of Leopard Lane to the intersection of East Eblin Street;

Following east along the center line of East Eblin Street to the intersection of South College Street;

Following north along the center line of South College Street to the intersection of East Travis Street;

Following east along the center line of East Travis Street to the place of the beginning;

Ending at the center of the intersection of East Travis Street, South Ellinger Road and FM 159;
