Option A: Driving Safety Course Request

(Please include payment of only \$146.00)

You may be eligible for a Driving Safety Course to have this charge dismissed if you meet the following requirements: (1) You must have a Texas Driver's License and you were NOT cited for 25 miles or more over the posted speed limit, and you were NOT driving 95 mph or more. (2) You have not taken a Driver's Safety Course 12 months prior to your citation date. (3) Remit payment in the amount of **only \$146.00** and **mail in Option A before or on the appearance date shown on the citation.**

Option B: Deferred Disposition Request

I enter a plea of Guilty No Contest

Violation(s): _____

You may be eligible to receive Deferred Disposition. Contact the court for eligibility requirements. If you request Deferred Disposition, and it is granted, the citation will not appear on your driving record. If you are younger than 25 years of age, you must complete a Driving Safety Course with this option. **Mail in Option B before or on the appearance date shown on the citation. Do not make a payment until the court has approved your request.**

Option C: Pay Fine

I enter a plea of Guilty No Contest

If you wish to pay the fine you must enter a plea of guilty or no contest before or on the appearance date shown on the ticket.

Option D: Trial Request – With this request, I am entering a plea of **NOT GUILTY** and requesting:
