

RESOLUTION NO. R25-014

A RESOLUTION OF THE CITY OF PAMPA, TEXAS, CALLING A RUNOFF ELECTION ON SATURDAY, JUNE 7, 2025, FOR THE PURPOSE OF ELECTING A MAYOR FOR A TERM OF FOUR YEARS; PROVIDING FOR EARLY VOTING AND FOR NOTICE OF THE ELECTION; AND PROVIDING FOR OTHER MATTERS RELATING TO THE ELECTION AND SETTING AN EFFECTIVE DATE.

WHEREAS, on May 3, 2025, the City of Pampa held a General Election for the purpose of electing a Mayor, Commissioner Ward 1, and Commissioner Ward 3 to the City Commission of the City of Pampa; and

WHEREAS, in accordance with Article VII, Section 5 of the Pampa Home Rule Charter, a candidate for the office of Mayor must receive a majority of the votes cast; and

WHEREAS, no candidate for Mayor received a majority of the votes cast at the General Election held on May 3, 2025, thereby requiring a Runoff Election pursuant to the Pampa Home Rule Charter and Texas Election Code Sections 2.021 and 2.023;

WHEREAS, the City has contracted with the Gray County Elections Administrator to conduct the City's runoff election, pursuant to Chapter 31, Tex. Elec. Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PAMPA, TEXAS:

Section 1. A Runoff Election is hereby ordered to be held at the Pampa City Hall on Saturday, June 7, 2025, between the hours of 7:00 a.m. and 7:00 p.m., for the purpose of electing a Mayor for a term of four (4) years.

Section 2. The candidates for such runoff election shall be for Jimmy Chaney and Mike Borger, the candidates in the general election receiving highest and second highest number of votes.

Section 3. Notice of this Runoff Election shall be posted at Pampa City Hall, 200 W. Foster Avenue, Pampa, Texas 79065, on the City's official website, and published in a newspaper of general circulation not later than the 15th day before Election Day, in accordance with Texas Election Code Sections 2.026 and 4.003.

Section 4. The Gray County Elections Administrator shall serve as the Early Voting Clerk for the Runoff Election. The mailing address for applications for a ballot by mail is:

Monday, June 2 – Tuesday, June 3, 2025: 8:00 a.m. to 5:00 p.m.

Section 6. Applications for ballots by mail must be received by the Early Voting Clerk no later than the close of business on **Tuesday, May 27, 2025**, in accordance with the Texas Election Code.

Section 7. In accordance with Chapter 32, Subchapter C of the Texas Election Code, all presiding and alternate judges, and clerks, appointed by the City Commission must be qualified voters of the City of Pampa and may not be employed by, or related within the second degree of affinity or consanguinity to, any candidate on the ballot.

Section 8. This Runoff Election shall be conducted in accordance with the Texas Election Code and applicable provisions of the Pampa Home Rule Charter. Election returns shall be delivered to the City Secretary, and the City Commission shall canvass the results and declare the outcome in accordance with law.

Section 9. This Resolution shall take effect immediately upon its passage.
