## Resolution and Order

Whereas, the term of office of Trustee Brett Britten; the term of office of Trustee John Connely; the term of office for Trustee Adrianna Fields; the vacancy created by the resignation of Trustee Garet Rocha; and the term of office for appointed Trustee Deke Alexander will expire on the First Saturday in May, 2025, said First Saturday being the 3<sup>rd</sup> day of May 2025;

Now, THEREFORE, BE IT RESOLVED AND ORDERED by the Groom Independent School District Board of Trustees, acting in open session on the 20th day of January, 2025;

### Election Order and Date

.....(1) that an election be held in said school district for the purpose of electing to the board of trustees two (3) trustees to serve a three-year terms and one (1) trustee to serve a one year unexpired term, said election to be held on the first Saturday in May 2025; being the 3<sup>rd</sup> day of May 2025;

### Election Day – Polling Location and Hours and Election Judge

.....(2) that said election shall be held in the Groom Community Center, located at 100 Broadway Street, City of Groom, County of Carson, and State of Texas; and further, that the polls at the above designated polling place shall, on election day, be open from seven o'clock (7:00), A.M., to seven o'clock (7:00), P.M.; additionally, this order hereby appoints Marion Pool as Election Judge and accordingly she is granted the authority to assign election clerks and election counters in accordance with State Law regarding such clerks and counters, with the wage for the election Judge, election clerks, and election counters to be set according to Texas State Law regarding such payments, with additional fees as required by law paid to the election judge for delivery of the ballots as authorized by Chapter 32, Section 32.092 of the Texas Election Code;

### Early Voting – Polling Location and Hours

.....(3) that early voting for the above designated election shall be conducted at the City Hall building located at 100 Broadway, City of Groom, County of Carson, and State of Texas, and that the said place of early voting shall remain open between the hours of 8:30 A.M. until 12:00 P.M., and 1:00 P.M. until 4:30 P.M., on each day for early voting which is not a Saturday, a Sunday, or an official State Holiday, beginning on the 12<sup>th</sup> day prior to election day, said day being on Tuesday, the 22<sup>nd</sup> day of April, 2025, and continuing through the 4<sup>th</sup> day preceding election day, that day being Tuesday, the 29<sup>th</sup> day of April, 2025, also remaining open on Wed. April 23, 2025 and Tue. April 29, 2025 from the hours of 7:00 A.M. until 7:00 P.M., and shall further remain open for emergency voting procedures as outlined in Texas State Law, including, but not limited to, the hours of 7:00 A.M. until 7:00 P.M. on the day of the election;


### Election Judges and Early Voting Clerk

.....(4) that election judges will be appointed and that Sherry Rocha (or her qualified replacement) is hereby appointed Early Election Clerk; and that the election judges and the early voting clerk are hereby granted the authority to assign election clerks and election counters in accordance with State Law regarding such clerks and counters, with the wage for the election Judge, election clerks, and election counters to be set according to Texas State Law regarding such payments, with additional fees as required by law paid to the election judge for delivery of the ballots as authorized by Chapter 32, Section 32.092 of the Texas Election Code;


.....(5) that the manner of conducting early voting by mail, e-mail, emergency absentee balloting, and the manner of holding said election shall be governed, as nearly as may be, by the election code of the State of Texas; and that the mailing address for the early voting clerk is P.O.
