THEN, County Judge, John C. Bullock, called the meeting to order and made note that all commissioners were present and that the meeting had been posted in the manor and for the time required.

Also, Auditor Cheryl Roberts presented a bill from Big Country Restaurant and Refrigeration Service for work done on dishwasher in the county Jail in the amount of \$915.40 and asked for the bill to be paid from Jail Development.

THÉN, Jimmy Wiley moved to approved payment for Big Country Restaurant and Refrigeration Service in the amount of \$915.40 see exhibit "F". Motion was seconded by Commissioner Stacey K. Rogers and carried 5-0.
