#### ITEM NO. 1 - Call to order - All stand if convenient

**THEN,** County Judge, John C. Bullock, called the meeting to order and made note that all commissioners were present and that the meeting had been posted in the manor and for the time required.

ITEM NO. 2 – Invocation, followed by the U.S. Pledge and Texas Pledge (Honor the Texas flag, I pledge allegiance to thee, Texas, One state under God, One and Indivisible)

**NEXT,** Commissioner Matt Pruitt offered the Invocation, followed by the U.S. Pledge and Texas Pledge.

## ITEM NO. 3 - County Judge, John C. Bullock opens the Public Hearing by openly stating the following:

## "1ST Public Hearing on Proposed Tax Increase" As required by Truth-In-Taxation

A hearing to formally adopt the budget and set the tax rates for maintenance and operations and for debt services has been set for Monday, September 10, 2018 @ 9:30 a.m. in the Young County Courtroom @ 516 Fourth Street, Room 106, Graham, Texas 76450.

Announcement: Calculation of the Tax Rates for Young County, Texas, were completed August 7, 2018, as follows:

Effective Rate - .735902 Roll Back - .799323 Debt Rate - .081454

A tax rate of \$.799000 per \$100 valuation has been proposed for adoption by the governing body of <u>Young County</u>. This rate exceeds the lower of the effective or rollback tax rate and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

**THEN**, County Judge John C. Bullock opened the court for public comment regarding the proposed tax rate that would increase taxes. Stating, this rate exceeds the lower of the effective or

rollback tax rate, outlined in Exhibit "A". The "Public Hearing" was attended by Jim C. Ross, wife, Mae Ross and Greg Speck public members of Young County, Texas.

## NOTE: PUBLIC ATTENDANCE WAS PRESENT IN THE COUNTY COURTROOM: James C. Ross spoke to the court about the rate being set and about the Hospital Tax Rate.

Much of the comments were directed toward appraisals rather than the tax rate proposed. A few questions were answered and explanations provided by members of the court. Judge Bullock invited more comment from those present; however, no other public member present chose to comment.
