ITEM NO. 1 - Call to order - All stand if convenient.

THEN, County Judge John C. Bullock called the meeting to order and noted all commissioners were present and the meeting had been posted in the manor and for the time required.

"PUBLIC HEARING" SPEED LIMIT CHANGE FOR ALL OR ANY PORTION OF ROCKY MOUND ROAD NOT EXCEED 45 MPH (Comments Pro or Con)

Chief Deputy Jim Budarf from the Young County Sheriff's Department borrowed equipment from the Graham Police Department and presented to the Court a survey that was conducted on or about April 7 thru April 19, 2016 on vehicle speed on Rocky Mound Road; outlined in Exhibit "A".

Citizens from Graham Texas who reside on Rocky Mound Road spoke to the court on speed Limit that they thought to be reasonable on this road:

- 1. Stanley David Robertson would like to have speed limit at 35 mph
- 2. Michelle Harvell would like to have speed limit at 40 45 mph
- 3. Darrell Weatherbee would like to have speed limit at 45 mph
- 4. Jacob Neudorf would like to have speed limit at 45 mph
- 5. Richard Scheriger would like to have speed limit at 45 mph
- 6. Doug Robertson would like to have speed limit at 45 mph
