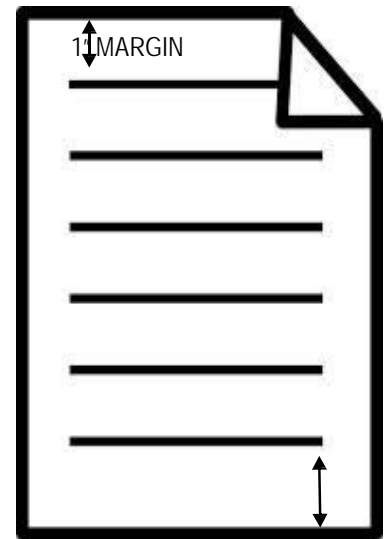

**RECORDING REQUIREMENTS FOR THE OFFICIAL PUBLIC RECORDS
 OF YOUNG COUNTY, TEXAS**
 (Effective January 1, 2017)

1. The charge to file a document in Young County's Official Public Record is \$26.00 for the first page and \$4.00 for each additional page. *(You can use the chart below to assist you in determining the fee for your document.)*
2. At the present time, Young County does not take electronic filings.
3. We accept documents on legal or letter size paper.
4. All documents must be original and notarized or certified copies from a court. (Property Code 12.001 & 12.011)
5. A one inch (1") margin is required at the top of each page of the document.
6. We receive documents from any carrier, but we use standard postal service to return documents. If you would like to use a specific carrier or would like the document delivered to you overnight, it is your responsibility to provide a prepaid envelope for the postal service you choose.
7. For documents with more than five (5) names to index, and additional fee of 25¢ per name will be assessed.
