OPTION NO. 2 - REQUESTING DRIVING SAFETY COURSE:

To be eligible you must:

- Have a Valid Texas Driver's License; and
- Not have a COMMERCIAL DRIVER'S LICENSE; and
- Not have taken the course within the last 12 months for dismissal of a ticket; and
- Not have been cited for 25 mph or more over the speed limit or a non-traffic violation.

• Not have been cited for 95 mph or more

• Send the following items, POSTMARKED BY THE APPEARANCE DATE NOTED ON YOUR TICKET:

- (1) this completed REPLY FORM; (2) proof of Liability Insurance; (3) copy of the ticket; (4) \$110.00 Court fee by CASHIER'S CHECK OR MONEY ORDER ONLY to Judge circled on front of the letter;
- (5) a self-addressed stamped envelope and (6) copy of your driver's license

The Court will notify you by mail if you qualify or not. You must enter a plea of NOLO CONTENDERE OR GUILTY, and complete the affidavit below. CHECK ONE:
