**Invocation and Pledge**

A motion was made by Comm. Belicek, seconded by Comm. Bubela to approve the agreement with Vista Solutions for the Tax Office and Permitting Office in the amount of \$600.00 per office and to come from the budgets of each office. Motion carried.

Comm. Bubela informed the Court of the E-Recycling event set on August 10<sup>th</sup> at the Transfer Station.


**ADJOURNMENT**

A motion was made by Comm. Belicek, seconded by Comm. Bubela to adjourn at 9:33 a.m.


