

Notice About 2023 Tax Rates

Property tax rates in Goliad County.

This notice concerns the 2023 property tax rates for Goliad County. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's no-new-revenue tax rate	\$0.722600/\$100
This year's voter-approval tax rate	\$0.769369/\$100

Voter-Approval Tax Rate Adjustments

Indigent Health Care Compensation Expenditures

The Goliad County spent \$93,581 from July 1, 2022 to June 30, 2023 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$28,451. This increased the voter-approval tax rate by 0.002550/\$100.

Indigent Defense Compensation Expenditures

The Goliad County spent \$103,576 from July 1, 2022 to June 30, 2023 to provide appointed counsel for indigent individuals, less the amount of state grants received by the county. In the preceding year, the county spent \$65,045 for indigent defense compensation expenditures. The amount of increase above last year's indigent defense expenditures is \$38,531. This increased the voter-approval rate by 0.000291/\$100 to recoup 5% more than the preceding year's expenditures.

This notice contains a summary of actual no-new-revenue and voter-approval calculations as certified by Michelle D Garcia, Goliad County Tax Collector/Assessor on 08/08/2023 .
