Call to Order.

1. Public Comments – public comments shall be limited to 3 minutes per presenter who submitted a public participation form at least 15 minutes prior to the start of the meeting. Comments must be pertinent to an agenda item or an area for which the Court has jurisdiction. The total amount of time that is allocated is 30 minutes for all comments.
2. Commissioners Court response to public comments.
3. Presentation of Governor Abbott's Proclamation announcing March as Development Disabilities Awareness Month.
4. Consider and take action to approve recommendations for no change in Voting Precinct Boundaries in compliance with Section 42.031 of the Texas State Election Code.
5. Consider and take action to authorize the Election Administrator to enter into Contracts with Local Entities for the May 3, 2024, Joint Local Election.
6. Consider and take action to authorize the Election Administrator to enter into an Interlocal Agreement with Liberty Eylau ISD for the lease of election equipment.
7. Consider and take action to approve the Resolution for application for the Victim Coordinator and Liaison Grant (VCLG)


