This includes ALL DIVISIONS within DPS: Texas Crime Information Center (TCIC); National Crime Information Center (NCIC); Texas Department of Emergency Management (TDEM); Texas Data Exchange (TDEx); National Data Exchange (N-Dex); Texas Highway Patrol (THP) (or local THP offices); Driver License Division (DL) (or local DL offices); Administrative License Revocation (ALR); Texas Homeland Security; Crime Records Service (CRS); Crime Lab; Texas Rangers; Sex Offender Registry Bureau (SOR), etc. It also includes everyone that utilizes FBI records: US Department of Justice (DOJ); US Immigration and Customs Enforcement (ICE); US Department of Homeland Security (DHS); etc</p>	<p>expunctions@dps.texas.gov</p>
