**All that certain lot, tract or parcel of land situated in the J. HENDERSON SURVEY, Abstract No. 346, Van Zandt County, Texas, being a 0.280 acre tract and a part of the same land described in a deed from J.L. Griffin to Everett Griffin and Daisy Watson dated February 18, 1949, and recorded in Volume 379, Page 192, Van Zandt County Deed Records, said 0.280 acre tract being more particularly described as follows:**

**BEGINNING at a 1/2" iron rod found in fence, said point being the Northeast corner of the above mentioned Everett Griffin and Daisy Watson tract, also being the Southeast corner of a called 132.208 acre tract described in a deed from Imogene Weatherall LaPrade to Margaret Ann Rodgers, dated April 13, 1993, and recorded in Volume 1278, Page 584, Real Property Records of Van Zandt County, Texas. Said point being North 89° 47' 05" East 7.2 feet from an axle found at fence corner, and being 40 feet from the centerline of F.M. Road No. 1652;**

**THENCE South 12° 03' 35" West along said road 125.00 feet to a 1/2" iron rod set for corner, said point being 40 feet from the centerline of said road;**

**THENCE South 89° 47' 05" West 100.00 feet to a 1/2" iron rod set for corner;**
