All that certain lot, tract, or parcel of land situated in the LEANDER SMITH SURVEY A-827, Van Zandt County, Texas, same being part of a called 72.41 acre tract as found in Warranty Deed dated April 25, 2019 from Mark C. Hannan and wife, Laurie Hannan to Billy Jack Deen as found recorded in Document No. 2019-003435 of the Real Records of Van Zandt County, Texas, and being more fully described as follows:

BEGINNING at a point within County Road 4210, in the West line of said Deen's 72.41 acre tract, and in the recognized West survey line of said Leander Smith Survey for the Northwest corner of this, from which a Steel Fence Corner Post was found and used for a reference bears South 89 deg. 17 min. 12 sec. East 18.91 feet, said beginning point being South 00 deg. 04 min. 48 sec. West 706.19 feet, and South 00 deg. 57 min. 04 sec. West 693.57 feet from a Mag. Nail set for the Northwest corner of said Deen's 72.41 acre tract;

THENCE: South 89 deg. 17 min. 12 sec. East 1473.38 feet to a point in the East line of said Deen's 72.41 acre tract for the Northeast corner of this, from which a Steel Fence Corner Post was found and used for a reference bears North 89 deg. 17 min. 12 sec. West 0.92 feet;

THENCE: South 00 deg. 52 min. 25 sec. West 0.91 feet with the East line of said Deen's 72.41 acre tract to a Wood Post found for an angle point of same;

THENCE: South 01 deg. 24 min. 02 sec. West 733.93 feet with the East line of said Deen's 72.41 acre tract to a 60d Nail found in the top of a X-tie fence corner post for the Southeast corner of said Deen's 72.41 acre tract;

THENCE: North 89 deg. 39 min. 00 sec. West 1467.69 feet with the South line of said Deen's 72.41 acre tract to a point within County Road 4210, and in the recognized West survey line of said Leander Smith Survey for the Southwest corner of said Deen's 72.41 acre tract, from which a 1/2" Iron Rod was found and used for a reference bears South 89 deg. 39 min. 00 sec. East 18.22 feet;

THENCE: North 00 deg. 57 min. 04 sec. East 744.10 feet with the recognized West survey line of said Leander Smith Survey, the West line of said Deen's 72.41 acre tract, and with County Road 4210 to the place of beginning containing 24.96 acres of land.
