FOR STATUS DOCKET CALL
CONCERNING MISDEAMEANORS

It is **ORDERED** that all defendants, with pending misdemeanor cases filed in the Rusk County Court at Law, who are NOT represented by an attorney for each misdemeanor case, must **APPEAR** (in person) at the Rusk County Henderson Civic Center located at Henderson's Lake Forest Park off Highway 64 West, Henderson, Texas 75654 for Docket Call on March 5, 2021 at 8:30 a.m.

Due to Covid-19, Docket Call is being held at a new location, the Rusk County Civic Center. All Defendants will be required to wear masks and social distance while in the Civic Center. Masks will be provided to anyone who does not have his or her own mask.

Failure to appear to Docket Call as ORDERED will result in the forfeiture of bond and issuance of an Arrest (CAPIAS) Warrant for the arrest of the Defendant, and upon arrest, setting of a cash bond to be released from jail.
