PRESS RELEASE

On April 25th of 2025 a Rusk County jury convicted a Longview man, David Roy Mundt, age 62 of two counts of Aggravated Sexual Assault of a Child for a 1992 crime where a seven-year-old child was taken from her bed and sexually assaulted in her back yard. The DPS Laboratory in Garland was able to isolate spermatozoa from the rape kit and obtain a DNA profile. Later the jury assessed punishment at Life in the Texas Department of Criminal Justice. Judge Parrish presiding by assignment of the 4th Judicial District Court ordered the sentences to be served consecutively, that is to say stacked.

The jury also heard evidence from a 1986 case where a three-year-old was taken from her crib and sexually assaulted in Phoenix Arizona. A DNA profile was obtained from the Arizona victim's panties. Additionally, the jury heard evidence from a third victim within the defendant's family.

The State was represented by DA Micheal E. Jimerson, Chief Prosecutor Alan Ross and ADA Tiffany Conner.
