Please find attached the City's Notice of Election for the May 6, 2023 General Election.

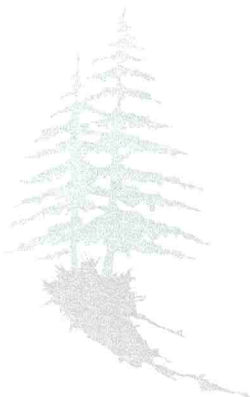
Crockett City Council approved the Notice on February 6, 2023 to elect Mayor and Council Members in Precincts 1 & 2.




