“CONSIDER AND TAKE APPROPRIATE ACTION ON A RESOLUTION AND ORDER AUTHORIZING THE COUNTY TO ENTER INTO A TAX ABATEMENT AGREEMENT PURSUANT TO THE COUNTY’S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE AS REQUESTED BY CH SOLTERRA SOLAR, LLC FOR APPROXIMATELY \$167,000,000 IN IMPROVEMENTS RELATED TO THE GENERATION OF ELECTRICAL ENERGY UTILIZING SOLAR PANELS. THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT COMPRISES APPROXIMATELY 1,500 ACRES AND IS LOCATED IN EASTERN HOPKINS COUNTY, APPROXIMATELY 2.3 MILES NORTH OF UNITED STATES HIGHWAY 67 WITHIN THE HOPKINS COUNTY BT SOLTERRA SOLAR REINVESTMENT ZONE NUMBER 1.
